DMACC Zone

 EHB responded to a complaint in SoMa and impounded 2 vendors (hot dog and tamales) during the day.

Neighborhood Street Team - Mission

- As part of the Neighborhood Street Team, EHB conducted education and outreach at 16th + 24th and Mission DAILY Monday through Friday, where 25 different vendors have been observed over the past 2 weeks (see attached).

Please see the below summary of events for last week (4/21-4/27), with 6 task force operations and 5 vendors impounded. Two ops cancelled by SFPD.

DMACC Zone

- EHB conducted two ops with a focus on Bill Graham concerts. 8 vendors observed and 3 impounded. Remaining vacated quickly.
- EHB was contacted by BG organizer, stating the vendors come out after the concert is over (after midnight). Discussing strategies on how to determine vendors from coming in. Including strategies that have worked at the ball park.

Neighborhood Street Team - Mission

- As part of the Neighborhood Street Team, EHB conducted education and outreach at 16th + 24th and Mission daily, where 23 different vendors were observed.
