Please find DPH's updates for next week's operations Objectives - Week of 06/21/2025 – 06/27/2025 below:

ILLEGAL FOOD VENDING:

Continue vacating all food vendors from the DMACC Area, Mission Corridor, Special Events (Chase Center, Ballpark, etc) during planned weekday/weekend missions

- On-going, with pre-mission briefings to take place prior to enforcement action and changes in time frame to account for more vendor activity at a later time in the evening.

DPH-EHB to receive feedback and responses regarding the drafts from Compact Mobile Food Operations (CMFO), which detail the application and permitting process by

10/27 (DPH-EHB). Meetings planned with stake holders for implantation of CMFO.

- On-going, for implementation/codifying of CMFO into local ordinance.

Coordinate with DPW, CAT, Port, Fire and other city agencies on city-wide vending policies and potential legislation.
