Afternoon Naveena and Dan,

Please see the below summary of events for last week (5/21-6/8), with 16 task force operations and 15 vendors impounded.

### **DMACC Zone**

- EHB participated in 3 night operations in TL/Bill Graham.
- No vending at Bill Graham from 7pm-11:30pm.
- Only 1 vendor at Hyde and Turk Street with food and equipment impounded.

### **Neighborhood Street Team - Mission**

- No DPH enforcement at this time, including impounding.

### **Chinatown**

- EHB participated in 4 operation where **27 vendors** were observed and 5 impounded, including raw fish and taco meat.
- Majority of vendors vacated area before taskforce could engage.

### **Port/Ball Parks**

- EHB participated in 6 operations at Oracle Park and Chase. **5 vendors were impounded out of 53 hot dog vendors observed.**

### **Complaints**

- EHB responded to community complaints and set up 3 operations at Union Street Festival, Masonic Auditorium, and Castro.
- Activity only observed in the Castro, with 3 out 4 vendors impounded.
